Environmental Connection, Inc., (EC) was contracted by the Bradley Beach Board of Education (BBBOE) to collect and provide laboratory analysis of water samples from the Bradley Beach Elementary School, located at 515 Brinley Avenue in Bradley Beach, New Jersey. Sampling was completed on October 11, 2024, between the hours of 6:00 AM and 7:00 AM.

Samples were collected from 16 locations, as follows:

- Spigot in Basement Custodial Storage Room (Point of Entry Sample)
- Water Chiller Fountain in Basement Hallway by Copy Room
- Water Chiller Fountain in Basement Hallway by Room 29
- Sink Faucet in Nurse's Office (Left)
- Sink Faucet in Nurse's Office (Right)
- Sink Faucet in Kitchen (Dishwash)
- Sink Faucet in Kitchen (Handwash)
- Water Chiller Fountain in Basement Hallway by Cafeteria
- Filtered Bottle Fill Station in Cafeteria (Basement)
- Water Chiller Fountain in First Floor Hallway by Main Office
- Water Chiller Fountain in First Floor Hallway by Room 10
- What Chiller Fountain in Second Floor Hallway by Room 15
- Sink Faucet in Second Floor Teacher's Lounge
- Sink Faucet in Room 22
- Sink Faucet in Room 21
- Sink Faucet in Room 20

Samples were collected in sterile 250 milliliter bottles, pre-treated with nitric acid solution (HNO₃). The sampling technician utilized new vinyl gloves at each testing location. At each location, a "first draw" sample was collected prior to any known usage of the fixture,

immediately after which the fixture was flushed for 30 seconds and a second draw sample was collected. Note: Flush draw samples were not collected from outlets incorporated with holding tanks. The samples were hand delivered to EMSL Analytical, Inc., (IATL) of Cinnaminson, New Jersey. EMSL is certified by the State of New Jersey, Department of Environmental Protection (NJDEP), for drinking water analysis.

Analysis was completed in accordance with United States Environmental Protection Agency (USEPA) Method 200.8. The USEPA and NJDEP Action Level of 15 parts per billion (ppb) or micrograms per liter (μ g/L) was used to determine if further testing and/or remediation is warranted. Where levels above 15 ppb or μ g/L were detected, analysis of the second draw sample was performed, in accordance with USEPA protocol.

Results of analysis are summarized in Table 1 below:

One (1) test location, the Basement Custodial Storage Spigot, exhibited a lead concentration above the USEPA and NJDEP Action Level of 15 parts per billion (ppb). The fixture in the Basement Custodial Storage is not a drinking or cooking outlet and therefore does not require remediation. Based on the results of analysis, EC recommends inspecting the service line that enters the building for lead components. If found, lead plumbing materials should be replaced. All other locations exhibited lead concentrations below the aforementioned threshold and therefore do not require remediation.




